### ITEMS FOR TECHNICAL PLAT REVIEW:

#### New Business:

- **1. LSP 14-4608: Lot Split (3220 OAKLAND ZION RD. /REO HOLDINGS, 218):** Submitted by BLEW AND ASSOCIATES for property located at 3220 OAKLAND ZION ROAD. The property is in the PLANNING AREA and contains 47.81 acres. The request is to split the property into two tracts containing approximately 32.98 and 14.83 acres.

- **2. CCP 14-4605: Concurrent Plat (ABSHIER HEIGHTS SUBDIVISION LOTS 13-24, 407):** Submitted by BLEW AND ASSOCIATES for property located at 1400 AND 1500 BLOCK OF NORTH DESOTO PLACE. The property is zoned RSF-8, RESIDENTIAL SINGLE-FAMILY, 8 UNITS PER ACRE and contains approximately 2.18 acres. The request is to re-plat 12 existing lots into 10 (nine single family and one detention pond lot). Planner: Jesse Fulcher
- 3. SIP 14-4610: Small Site Improvement Plan (2890 N. COLLEGE AVE. /MEDEXPRESS, 252): Submitted by MORRISON SHIPLEY for property located at 2890 NORTH COLLEGE AVENUE. The property is zoned C-2, THOROUGHFARE COMMERCIAL and contains approximately 1.65 acres. The request is to remodel the existing retail building and parking lot for a new medical facility.

- **4. PPL 14-4609: Preliminary Plat (5450 E. HUNTSVILLE RD. /QUARRY TRACE COMMONS, 571):** Submitted by MILHOLLAND COMPANY ENGINEERING AND SURVEYING for property located at 5450 EAST HUNTSVILLE ROAD. The property is zoned RSF-4, RESIDENTIAL SINGLE-FAMILY, 4 UNITS PER ACRE and contains approximately 35.90 acres. The request is for a residential subdivision with 115 single family lots.
