AN ORDINANCE TO AMEND §111.30 RETAIL IN CHAPTER 111: ALCOHOLIC BEVERAGES OF THE CITY CODE TO ALLOW PRIVATE CLUBS AND ON PREMISES CONSUMPTION HOTEL, MOTEL, AND RESTAURANT ALCOHOL PERMIT HOLDERS TO SELL, SERVE OR PERMIT THE CONSUMPTION OF CONTROLLED BEVERAGES BEGINNING AT 7:00 A.M. MONDAY THROUGH SATURDAY
BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FAYETTEVILLE, ARKANSAS:
Section 1: That the City Council of the City of Fayetteville, Arkansas hereby amends section §111.30(D) <i>Private Club Permit</i> by repealing subsection (D)(3) <i>Hours of operation and</i> enacting a replacement subsection (D)(3) as follows:
"(3) <i>Hours of Operation</i> . It shall be unlawful for the owner, operator, or any employee of a private club to serve or permit the consumption of any controlled beverages on the premises of said private club between the hours of 2:00 a.m. and 7:00 a.m. on any day."
Section 2: That the City Council of the City of Fayetteville, Arkansas hereby amends §111.30(E) On Premises Consumption – Hotel, Motel or Restaurant Permit by repealing subsection (E)(3) Hours of operation and enacting a replacement subsection (E)(3) as follows:
"(3) Hours of Operation. It shall be unlawful for any person holding an on-premises consumption hotel, motel or restaurant permit to sell, offer for sale, serve, give away, or permit consumption of any controlled beverages between the hours of 2:00 a.m. and 7:00 a.m. on Monday through Saturday, on Sunday except between the hours of 10:00 a.m. until midnight, on Christmas Day, or during any 24-hour interval designated an emergency period by the mayor, City Council, or any person acting in the Mayor's or the City Council's capacity."
