#### **RECOMMENDATION:**

Staff recommends approval of a bid waiver authorizing the purchase of 18, SCAR 16CQC rifles, from TK Tactical Firearms, to replace the Fayetteville Police Department Emergency Response Team rifles.

#### **BACKGROUND:**

The rifles used by the Fayetteville Police Department's Emergency Response Team were purchased in September of 2010 and have had reached their safe and practical "end of life". This project is a scheduled replacement.

#### **DISCUSSION:**

TK Tactical Firearms is the only distributor authorized by FN America to facilitate the sale of the SCAR 16CQC to the Fayetteville Police Department. TK Tactical will also allow us to trade in our current inventory of used rifles, offsetting some of the cost.

#### **BUDGET/STAFF IMPACT:**

This is a funded Capital Improvement Project in the amount of \$43,403.44 plus tax.
