SUBJECT: Staff recommends approving the purchase of forty (40) Getac tablet computers for the Police Department, through the National IPA Technology Solutions cooperative purchasing agreement 2018011-01, from CDWG Inc., in the amount of \$145,360.00 plus applicable taxes.

RECOMMENDATION:

Staff recommends approving the purchase of forty (40) Getac tablet computers for the Police Department, through the National IPA Technology Solutions cooperative purchasing agreement 2018011-01, from CDWG Inc., in the amount of \$145,360.00 plus applicable taxes.

BACKGROUND:

The Police Department utilizes ruggedized computers within patrol vehicles to access computer aided dispatch, mobile messaging, automatic vehicle locations systems, ticket writing software, accident reconstruction software, access to network documents, and enable officers to research driver's license and license plate information. Patrol vehicle computers have become a critical tool for Police operations due to the amount of information officer's access. The majority of the current computers were purchased in late 2014 and early 2015 and most warranties will expire in the next two (2) months. The current computers have reached the end of their useful life and have started to experience increased technical issues in the past six (6) months.

DISCUSSION:

Information Technology (IT) and Police staff reviewed computers from DataLux (current Police and Fire computer brand), Panasonic, and Getac. Each computer was installed in a patrol vehicle and evaluated by officers for approximately six (6) weeks. At the end of the evaluation staff selected Getac as the best solution for officer needs. The selected Getac A140 computer contained the largest screen evaluated, a matte finish screen that reduced glare, rugged construction, full warranty, and was the lowest cost. IT staff obtained multiple quotes and the lowest quote was from CDWG through the National IPA contract 2018011-01. City Council approved the use of this contact, through resolution 273-18, at the December 18, 2018 City Council meeting.

BUDGET/STAFF IMPACT:

Funds are available within the Police Mobile Computer Terminal Replacement CIP project as part of the Sales Tax Capital Improvements fund.
