SUBJECT: Request for Public Hearing on a Certificate of Public Convenience and

Necessity for Ambassador Taxi Company.

### RECOMMENDATION:

The council should schedule a public hearing to determine if a Certificate of Public Convenience and Necessity should be issued to Ambassador Taxi Company.

### **BACKGROUND:**

City Ordinance 117 article IV governs taxicabs and requires a public hearing to determine if there exists the further need for taxicab service. Dane Zimmerman owned Ambassador Taxi Company and was approved for a certificate of public convenience and necessity on March 17, 2015. Bill Deatherage purchased the company on July 29, 2016. City Attorney Kit Williams was made aware of the sale of the company and stated the new buyers needed to seek approval of the City Council for the assignment of the Certificate of Public Convenience. An application for Certificate of Public Convenience and Necessity was presented to the City Council on March 21, 2017 and approved. The certificate was vacated in 2018.

### DISCUSSION:

Attached is the application for Ambassador Taxi Company. The application contains all information needed as listed in City Ordinance 117.32. The City of Fayetteville currently has three taxi companies: Fayetteville Taxi, Payless Taxi and Dynasty Taxi Service. Fayetteville Taxi has a minimum of only one vehicle and one permitted driver. Payless Taxi currently has two vehicles permitted, but one permitted driver. Dynasty Taxi has not had any vehicles permitted in 2020 and have not had any drivers permitted in 2020. Their insurance is still current, but they are no longer taking calls for service in our city.

Application filed June 21, 2018 with the Arkansas State Highway Commission by Destiny Limousines, LLC/Deatherage Transportation, LLC, an Arkansas corporation doing business as Ambassador Transportation, seeking authority to operate as a contract carrier by motor vehicle in intrastate commerce transporting passengers, under continuing contract(s) between all points and places in the State of Arkansas, over irregular routes, as set forth in the application and notice of hearing.

A protest was filed by Stewart Larrabee to the application, and after due notice the matter was heard by the Commission's duly-appointed Hearing Officer on July 23, 2018. The hearing was held pursuant to the Commission's rules and regulations at its hearing offices, Arkansas Department of Transportation, Little Rock, Arkansas.

### **FINDINGS**

Upon full consideration of the evidence and all matters and things involved herein, and being well and sufficiently advised in the premises, we find the requested service to be in the public interest and in furtherance of the state transportation policy. The applicant is fit, willing and able properly to perform the proposed service and to conform to the requirements of the Motor Carrier Act and rules and regulations thereunder. We further find that no valid basis to deny the granting of authority was presented by the protestant. We further find that the application should be granted.

### ORDER

IT IS, THEREFORE, ORDERED, that the application of Destiny Limousines, LLC/Deatherage Transportation, LLC, an Arkansas corporation doing business as Ambassador Transportation, for authority to operate as a contract carrier motor vehicle, in intrastate commerce, be, and is hereby granted, subject to such conditions and limitations as are now or may hereafter be attached to the exercise of the privileges herein granted.
