Subject: Purchase of Eight Zero-Turn Mowers for Parks

Units 5068, 5069, 5074, 5075, 5076, 5077, 5078 and 5079 are all either 2016 or 2017 Hustler Super Z Mowers that have exceeded their life expectancies. All are within the points range for replacement, except for unit 5076 which is shy on points. 5076 is being replaced to keep consistent equipment.

Seven new Hustler Super Z mowers with 60" decks and side discharge systems are available for \$9,738.00 each, and one Hustler Super Z Mower with 60" rear discharge deck is available for \$9,834.00, off the Sourcewell contract. The total combined price of all eight mowers is \$78,000.00 available through Williams Tractor, of Fayetteville, AR.
