A meeting of the Fourth Judicial District Drug Task Force Control Board was held on August 18, 2021. This meeting was held at the Washington County Sheriff's Office, 1155 Clydesdale Drive, Fayetteville, Arkansas.

The meeting was called to order by Chief Mike Reynolds. Upon roll call, the above listed members were acknowledged present. Copies of the minutes from the July 21, 2021 meeting were distributed to all present. A motion was made by Jay Cantrell, and seconded by Mike Peters, to approve the minutes. The motion was approved unanimously.

The grant award has not been received at the time of this meeting.  
Should be receiving the JAG application in November or December.

Sergeant Tyler Moore reported on the task force's activity July 1, 2021 through July 31, 2021 and distributed a copy of statistics to all present. Moore stated that in July the task force opened 21 cases, closed 12 cases, and made 19 arrests. Moore further noted that \$2,525.00 was expended for the purchase of evidence, \$0.00 for the purchase of service, and \$540.00 for the purchase of information. Moore stated that drugs seized during the month included: Methamphetamine, Marijuana, Heroin, LSD, Ecstasy, and pharmaceuticals. Moore stated that 3 warrants were served. Also noted, 19 drug convictions for the month of July. The task force seized 0 vehicles and a total of \$22,386.00 in U.S. Currency during the month. The locations of DTF Enforcement Action

for the month were: Fayetteville 9 cases, Springdale 6 cases, Tontitown 1 case, Prairie Grove 1 case, and Lincoln 4 cases.
