Project Safe Neighborhoods (PSN) Grant Award For the Fourth Judicial District Drug Task Force

RECOMMENDATION:

Staff recommends acceptance of the Project Safe Neighborhoods (PSN) Grant Award to the Fourth Judicial District Drug Task Force (4<sup>th</sup> JDDTF) and approval of a budget adjustment in the amount of \$28,765.00.

#### BACKGROUND:

The 4<sup>th</sup> JDDTF was awarded the initial PSN grant on January 8, 2020, and we applied for the award renewal on November 21, 2021, to the Department of Finance & Administration, Office of Intergovernmental Services. In partnership with the U.S. Attorney's Office for the Western District of Arkansas, the PSN grant is designed to create and foster safer neighborhoods through a sustained reduction of violent crime. The program's effectiveness depends on partnerships of local, state, and federal law enforcement agencies working together with the communities they serve. As the fiduciary of the 4<sup>th</sup> JDDTF, Fayetteville will administer grant funds through its project accounting system.

#### **DISCUSSION:**

The 4<sup>th</sup> JDDTF will utilize the PSN grant funds to enhance their investigation of narcotics trafficking and assist with investigations involving a nexus to firearms, drugs and violence. The funds will also be used to train patrol officers of area law enforcement agencies to recognize cases that could be potentially prosecutable under the PSN parameters, and advise them on investigative procedures. As a result of this training, seizures of firearms should increase, thus making neighborhoods safer.

#### **BUDGET/STAFF IMPACT:**

There are no matching funds associated with this grant. A budget adjustment in the amount of \$28,765.00 will be added to the 2022 operating budget. There is no impact on staffing.
