A RESOLUTION TO APPROVE A BUDGET ADJUSTMENT IN THE AMOUNT OF \$1,244,144.00 ALLOCATING PROCEEDS FROM THE SALE OF THE SOUTH PLAZA PROPERTY TO REINDL PROPERTIES INC.

WHEREAS, on November 7, 2023, the City Council passed Resolution 251-23 authorizing Mayor Jordan to sell approximately 0.5 acres of City property at the south end of the Civic Plaza to Reindl Properties, Inc.; and

**WHEREAS**, the closing occurred on December 22, 2023, and the City received funds in the amount of \$1,244,144.00.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FAYETTEVILLE, ARKANSAS:

<u>Section 1</u>: That the City Council of the City of Fayetteville, Arkansas hereby approves a budget adjustment in the amount of \$1,244,144.00, a copy of which is attached to this Resolution, allocating proceeds from the sale of the South Plaza property to Reindl Properties, Inc.

### **RECOMMENDATION:**

Staff recommends approval of a Budget Adjustment for allocation of the proceeds from the land sale with Reindl Properties Inc. for the South Plaza property per resolution 251-23 for approximately 0.5 acres in the amount of \$1,244,144.00.

#### **BACKGROUND:**

In November 2023, council passed resolution 251-23 authorizing the Mayor to sign a real estate purchase contract with Reindl Properties Inc. for the sale of approximately 0.5 acres of City Property.

#### **DISCUSSION:**

As stated in the resolution 251-23 packet, the proceeds of the sale would be used for a trail easement purchase, public restrooms and parks storage within the hotel. Net proceeds would be used for the Plaza project. This budget adjustment places those funds in the project for disbursement.

### **BUDGET/STAFF IMPACT:**

Funds to be transferred from the Sale of Assets Account 4470.001.9470-4881.02 to the Plaza Project Account 4470.140.8900-5804.00.
