FORD RE-ORDER - REPEAL 69-23:

A RESOLUTION TO REPEAL RESOLUTION NO. 69-23; TO AUTHORIZE THE PURCHASE OF TWO VEHICLES FROM LEWIS FORD OF FAYETTEVILLE IN THE TOTAL AMOUNT OF \$112,202.34; TO AUTHORIZE THE PURCHASE OF TWO VEHICLES FROM SUPERIOR AUTOMOTIVE GROUP OF SILOAM SPRINGS IN THE TOTAL AMOUNT OF \$83,771.00; TO AUTHORIZE A CONTINGENCY FOR ANY APPLICABLE SURCHARGES, FREIGHT CHARGES AND DELIVERY FEES UP TO 10% OF THE ORIGINAL PURCHASE PRICE; AND TO APPROVE A BUDGET ADJUSTMENT

WHEREAS, Resolution 69-23 was passed March 21, 2023 approving the purchase of five vehicles from Lewis Ford in Fayetteville but, due to supply chain issues, Ford had to cancel government orders including this purchase; and

WHEREAS, Ordinance 6491, passed by the City Council on October 5, 2021, waived competitive bidding for the purchase of new vehicles but authorized the Fleet Division to solicit informal bids or quotes prior to the purchase of vehicles without the need for further approval by the City Council.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FAYETTEVILLE, ARKANSAS:

Section 1: That the City Council of the City of Fayetteville, Arkansas hereby repeals Resolution No. 69-23.

Section 2: That the City Council of the City of Fayetteville, Arkansas hereby approves the purchase of two vehicles from Lewis Ford of Fayetteville in the total amount of \$112,202.34.

Section 3: That the City Council of the City of Fayetteville, Arkansas hereby approves the purchase of two vehicles from Superior Automotive Group of Siloam Springs, Arkansas in the total amount of \$83,771.00.

Section 4: That the City Council of the City of Fayetteville, Arkansas hereby approves a contingency for any applicable surcharges, freight charges, and delivery fees up to 10% of the original purchase price.

Section 5: That the City Council of the City of Fayetteville, Arkansas hereby approves a budget adjustment, a copy of which is attached to this Resolution.

RECOMMENDATION:

A RESOLUTION TO REPEAL RESOLUTION NO. 69-23 AND AUTHORIZE THE PURCHASE OF (2) VEHICLES FROM LEWIS FORD SALES OF FAYETTEVILLE AR IN THE AMOUNT OF \$112,202.34 AND (2) VEHICLES FROM SUPERIOR AUTOMOTIVE GROUP OF SILOAM SPRINGS AR FOR THE AMOUNT OF \$83,771 PLUS ANY APPLICABLE SURCHARGES, FREIGHT CHARGES AND DELIVERY FEES UP TO 10% OF THE ORIGINAL PURCHASE PRICE AND TO APPROVE A BUDGET ADJUSTMENT.

BACKGROUND:

Resolution 69-23 was approved March 21st 2023, however due to supply chain issues, Ford had to cancel government orders affecting this purchase.

2165 is a 2013 Ford F150 with a current FASTER score of 15 points.

2160 is a 2013 Ford F250 with a current FASTER score of 14.4 points.

Unit 2284 is an approved 2023 expansion Ford F250 for the Parks Department.

Unit 1418 is an approved 2023 expansion Ford Escape for Community Resources.

DISCUSSION:

Council approves a resolution to repeal resolution 69-23 and authorize the purchase of these (4) vehicles from two different local dealers. Unit 2165 will be replaced with a Ford Explorer. Unit 2160 will be replaced with a Ford F250 with a utility body. Both expansion units 2284 PRKS_F080 and 1418 ANSV_F004 were approved with the 2023 budget by City Council.

BUDGET/STAFF IMPACT:

These items were unanimously re-approved at the January 9th Equipment Committee. A budget adjustment is being presented for your approval.
